# Demonstration Team Charter

## **Purpose Statement**

The University of Oregon's demonstration team ("Team") will be used to manage community education and demonstration requests, monitor and assess activity, plan and manage responses as needed and coordinate communication between activist groups and the university. This team will coordinate with the broader Incident Management Team should a demonstration become a civil unrest incident.

### Responsibilities of the team include

- Monitor scheduled events, and pursue traditional and social media intelligence to anticipate the potential for demonstrations.
- Develop pre-plans for general and emergency response staffing of events with the potential for demonstrations or civil unrest.
- Staff demonstration events to monitor the situation and report any issues back to Safety & Risk Services.
- Conduct post-event/incident evaluations to identify challenges and opportunities and to identify and implement corrective actions.
- Coordinate through the Incident Management Team should the demonstration become a civil unrest incident.
